



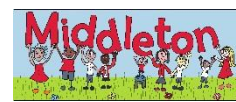

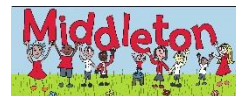
The proposal for consultation



- Five local schools to form a multi academy trust and convert to academy status:



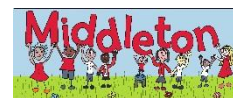
- To enable the schools to continue to provide an excellent education and achieve outstanding outcomes for all our pupils

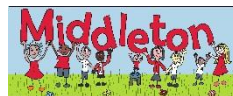

1) Leadership

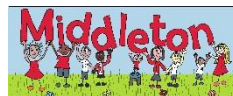
All young people and adults make a positive and exciting contribution to the life of the school and local community through the development of leadership skills.

4) Courage/Resilience/Determination

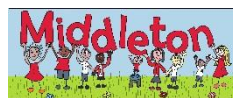
Having the courage and resilience to take risks with our learning to achieve beyond our expectations, and having the determination to succeed.

How the Trust will benefit pupils



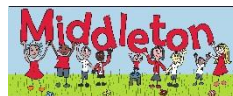

- Developing a 'core offer' of Trust-wide programmes and activities



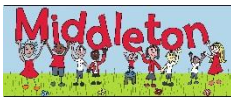
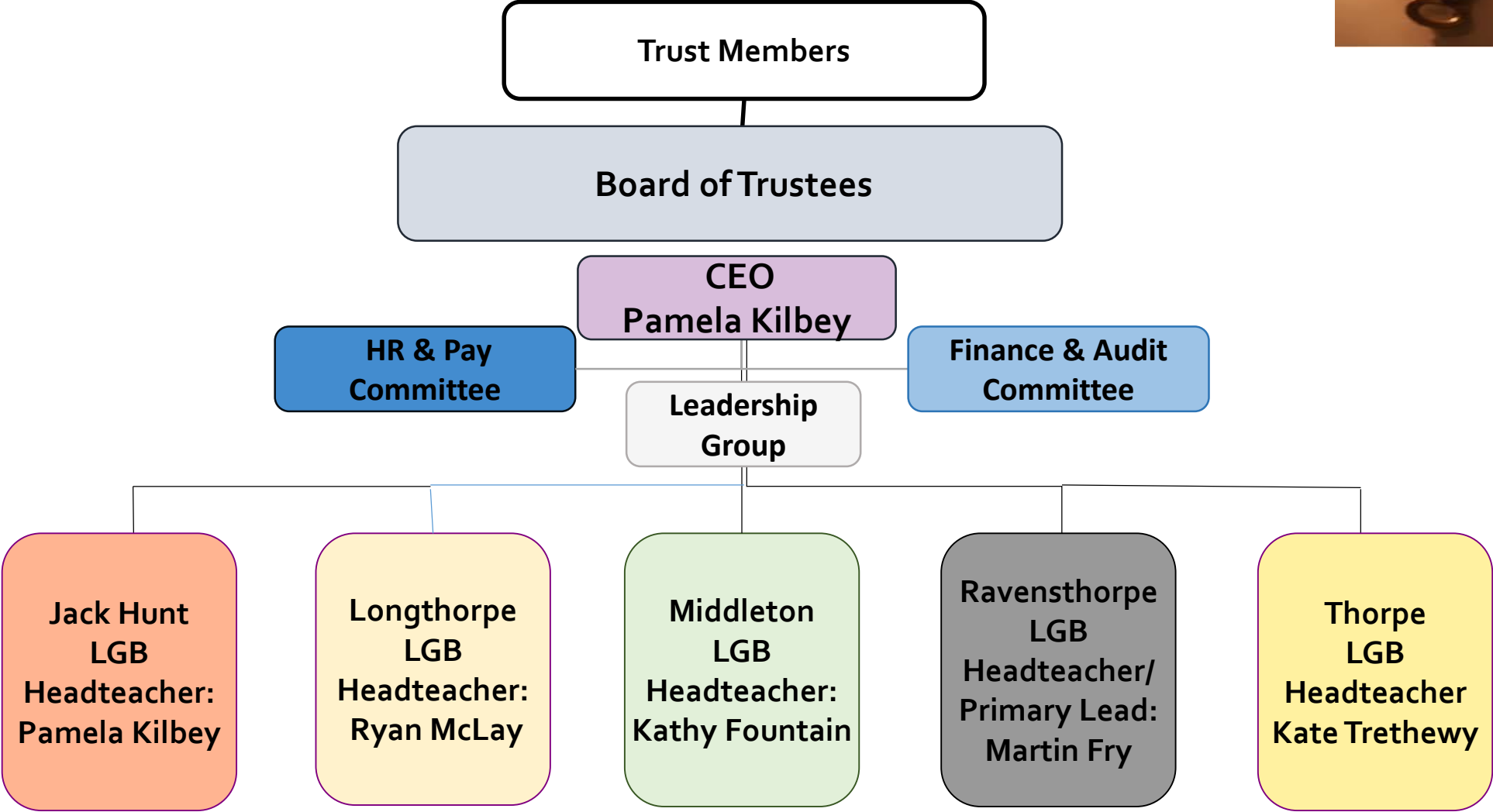

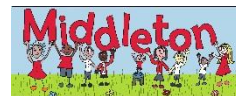
Structure of the MAT
